# **New Business**

## 6:30 PM Appeal No. 2008-016 Scandurra

Patricia M. Scandurra applied for and was granted a Comprehensive Permit under Chapter 40B of the General Laws of the Commonwealth of Massachusetts, and in accordance with Article II of Chapter Nine of the Code of the Town of Barnstable. Patricia M. Scandurra no longer owns the property and the new owners do not wish to participate in the Program so therefore Comprehensive Permit No. 2008-016 must be rescinded. The subject property is addressed as 415 Cedar St, West Barnstable, MA as shown on Assessor's Map 108 as Parcel 007-002. It is zoned Residence F (RF).

Comprehensive Permit Number 2008-016 was issued to the applicant on February 27, 2008 and a Regulatory Agreement and Declaration of Restricted Covenants were recorded at the Barnstable Registry of Deeds May 6, 2008.

#### **Procedural & Hearing Summary:**

A public hearing to rescind Comprehensive Permit No. 2008-016 was duly advertised and notice sent to abutters and the property owner all in accordance with MGL Chapter 40A. The hearing was opened on February 7, 2024 at which time the Hearing Officer, Jacob Dewey, made the following findings and decision:

#### **Findings of Fact:**

- 1. The applicant, Patricia M. Scandurra, was granted a Comprehensive Permit 2008-016 for an accessory affordable apartment at 415 Cedar Street, West Barnstable, MA on February 27, 2008.
- 2. The new owners of the property do not wish to participate in the program.
- 3. On December 28, 2023, the Accessory Apartment Program Coordinator took action to rescind Comprehensive Permit No.2008-016.

#### Ordered:

Comprehensive Permit number 2008-016 is rescinded.

A written copy of this decision shall be forwarded to the Zoning Board of Appeal as required by the Town of Barnstable Administrative Code Chapter 241, section 11. If after fourteen (14) days from that transmittal the Members of the Zoning Board of Appeals takes no action to reverse the decision, this decision shall become final and a copy shall be the filed in the office of the Town Clerk.

Appeals of the final decision, if any, shall be made to the Barnstable Superior Court pursuant to MGL Chapter 40A, Section 17, within twenty (20) days after the date of the filing of this decision in the office of the Town Clerk. The applicant has the right to appeal this decision as outlined in MGL Chapter 40B, Section 22.
