 Main Street, Hyannis Winn Companies is requesting \$2,000,000 in support of the Harbor Vue project, a new, ground-up construction of 120 units in a 96,829 square foot structure replacing a currently vacant building at 307 Main Street, Hyannis. The development program includes approximately 120 units of mixed-income housing for the workforce and families, earning a range of incomes, from affordable units (30-60% Area Median Income; 77 total), middle income (100-120% Area Median Income; 32 total), and market rate (11 total). 45 units will be permanently deed-restricted affordable to households at 60% of the Area Median Income.
