



Town Council Meeting
May 17, 2018



A quorum being duly present, Council President Eric Steinhilber called the May 17, 2018, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Steinhilber regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Steinhilber followed by a moment of silence.

President Steinhilber stated that occasionally the Council likes to recognize people in our community that are doing something special in Barnstable. Town Councilor, Jenn Cullum thought the Council could highlight the good works of the people in our community, this became Hometown Hero Award.

Hometown Hero: Lenore Lyons, the Key Idea, Inc.

Introduced by Councilor Beedenbender recognizing Lenore Lyons for giving back to our community; this hometown hero is raising our community up and helping the town thrive. The Key Idea gives voice to people who do not have one. Lyons shared many works of art from people of all ages.

President Steinhilber and Councilor Beedenbender presented the Hometown Hero Award to Lenore Lyons.

PUBLIC COMMENT:

Kathy Duran of Hyannis has concerns about the Department of Public Works using the BHS fields as a location for wastewater discharge. Duran asked the Council if there would be a time for neighbors and friends to speak to this issue. (Exhibit A)

Matthew Cuneo explained over the past 20 years we have watched the pond expand; some of my neighbors can no longer have a basement under their houses. This does not make common sense to do this to the fields. Millions of gallon of grey water will enlarge the footprint of the pond.

Peter Christian said my dog is protective, chased down a policeman and bit him. The dog is nervous around police officers, and just wants to be left alone. This has to stop, I'm about to start carrying weapons again.

Dan Santos, Director of Public Works Department shared with the Council state recognition of the Town's management of the Hyannis Water System. The award is a regional recognition for implementing long term planning to improve the water supply system Thank you to Hans Keijser, Hyannis Water Supervisor.

President Steinhilber asked for the Council's support to sign the letter regarding House bill 4045 and Senate Bill 2300; as it is time sensitive; all were in agreement.

Economic Development Program

Peter Lent, Economic Development Coordinator, discussed the need to start with an analysis of the strengths, weaknesses, opportunities and development that exist in Barnstable. We will be utilizing ad hoc groups, to do the analysis and to come up with a deliverable action plan.

Councilor questions and comments:

Economic development is our top priority; looking at zoning changes; to open up opportunities, we are moving in a great direction. Continue to keep us updated. How will the Ad Hoc member be chosen or can people apply [Lent, it may be task groups that are specific to the technical expertise of the area; rather than a committee, a more specific group; feedback will have your input as well] Make sure we utilize our civic associations as much as possible. Do you imagine a Town Manager task force [Ells, yes, depending on the objective, we have tremendous talent in our community; we will make sure we represent our entire community] Will you break this down by category; will you be working closely with licensing [Lent, site plan review process collaborates with the customer to successfully complete projects in a timely manner] How can we get Mass DOT to repair the potholes and pick up the trash on Route 28, please do what you can to make something happen [Ells, will do that personally, will call tomorrow] Litter on Route 6 is incredibly bad [priority will be communicated with the state] [how diligent would you like us to be in fining people who litter?] Do it! Can we require tarping of trucks [currently, that is an ordinance] Businesses want to do their part to help clean up, fine people, mandatory tarping, take this on as an important issue. People will continue to throw nip and/or alcohol bottles and cans out the window of a car or truck unless you allow open alcohol containers in motor vehicles. All communities should have an annual clean up day, will organize all the civic associations to organize and clean up our town. We need an awareness campaign, education that needs to be emphasized again, take pride in our

community. [Ells, agrees an educational program, to communicate keeping our town beautiful] Osterville had a clean up last Saturday.

[Work on our grants; tedious job, mostly processing payments] What does a noise abatement officer do [significant issues with noise, implemented various noise procedures, on line flight tracking system; dedicated noise line, have asked our tenants to fly quiet] look forward to the RFP coming in for the Capetown Plaza; on reducing the impact on our reserves, share what you envision as revenue increases [have not made significant projections, providing parking spaces for companies, hospital, places that are running out of space] how much does that raise [about \$20,000] Wish Bud well in his retirement.

Councilor questions and comments

Cost per student, is it the same for out of district students [figure includes in and out of district students] new staff coming in [12 retirements this year, predicting large retirement in about 4 to 5 years] what is the expectation for the student to provide their own gear [we want to provide equipment to protect the students] so for hockey do the students pay for their own gear [we don't always provide everything] explain what a chrome cart is [chrome books are laptops, these laptops slide into the carts to charge and store them] big difference in \$\$\$ between early students and high school students [multiple units within the cart, this is to supplement our technology budget] [to have enough devices for all of our students, 30 laptops in the cart, this is a large scale purchase] seventh and eighth grade seem to fall not meeting the state [our state testing is testing our curriculum, we need to align our curriculum, working on that this year] one out of three of our students are economically challenged, still troubled that the students are leaving to go to other schools. [Competitive market place today for students] School safety and security where is that in the budget [safety is carried within the Barnstable Police Department] [All staff will participate in Alice training, we pick up that cost] what percentage of our town residents have children in the school system [do not have that figure] Annual allocation of a 60 40 split [that agreement has been in effect since 2003] perhaps you should look at other districts, when you predict the enrollment going down, our residents are getting older [cape cod collaborative superintendents to do some planning with us; we are certainly on the lower end of that, we educate the most diverse students, open to having those discussion with the Town Managers] is it because of the specialized education the FTE's have risen [For 10 percent of our student population, English is a second language] Seventh grade concerns me, big drop in results, unsure about the school and instruction; see the value in our youth, the Achievers program is so important [graduation rate data has gone up three percent] community effort; many of our schools are getting more students that are autistic, is that also effecting an increase in the budget [the children need to be educated with their peers, we do have an increase in the numbers of Autistic children] MCAS trends, hovering around the 50 to 60 percentile, then in grade 10 the numbers are off the chart. [the test is for an 8th grader] our school system attracts people, Barnstable well represented in the rising stars.

§ 86-7

A. Establishment.

The Town hereby establishes revolving funds, pursuant to Chapter 44, § 53 E 1/2 of the General Laws, within the special revenue accounts of the Town of Barnstable and for use by the designated town departments and officers in connection with the operation of programs or activities that generate fees, charges or other receipts to support all or some of the expenses of those programs or activities.

B. Authorized Revolving Funds.

- (1) Classroom Education Fund, Senior Services Division operated by the Community Services Department.
- (2) Recreation Program Fund, Recreation Division operated by Community Services Department.
- (3) Shellfish Propagation Fund, Natural Resources Division operated by the Marine & Environmental Affairs Department.
- (4) Consumer Protection Fund operated by Licensing Department.
- (5) Geographical Information Technology Fund, Information Technology Department operated by Administrative Services Department.
- (6) Arts and Culture Program Fund operated by Planning and Development Department.
- (7) Asset Management Fund operated by Town Manager Department.

§ 86-8 Operation and Procedures

The Senior Services Division and the Recreation Division of the Community Services Department, the Licensing Department, the Information Technology Department of the Administrative Services Department, the Planning and Development Department, the Marine and Environmental Affairs Department and the Town Manager Department are hereby authorized to operate said funds in the following manner:

A. Revenues

The Finance Director shall account for all funds separately from all other monies of the Town and to which shall be credited only the departmental receipts received in connection with the programs supported by such revolving fund. Receipts credited to each of these revolving funds shall mean the following:

- (1) For the Classroom Education Fund and the Recreation Program Fund: program registration fees to participate in these programs.
- (2) For the Shellfish Propagation Fund: fees generated from the sale of commercial and recreational shellfish permits and the sale of shellfish related merchandise.
- (3) For Consumer Protection Fund: fees generated for services performed under the weights and measures program.
- (4) For the Geographical Information Systems Fund: fees generated for the production of GIS maps and reports.
- (5) For the Arts and Culture Program Fund: lease payments received from the rental of artist shanties, gifts or contributions received for the support or promotion of arts and

culture programs and any revenue generated from Town-sponsored arts and culture programming.

(6) For the Asset Management Fund: proceeds from the sale of tax foreclosed property and other town owned property not specifically required to be accounted for subject to any other general law for the support and promotion of any expenditure related to the Town's comprehensive asset management program.

B. Expenditures

Expenditures may be made from the revolving funds established and authorized by this ordinance without further appropriation, subject to the following:

(1) Expenditures shall not be made or liabilities incurred from any of the revolving funds in excess of the balance of the fund nor in excess of the total authorized expenditures from such fund. Expenditures from such revolving funds shall be at the approval of the Town Manager or their designee.

(2) Expenditures from said fund shall not be made for the purpose of paying any wages or salaries for full-time employees unless the fringe benefits associated with such wages or salaries are also charged to the fund. Subject to the foregoing, the funds may be expended for payment of teachers, recreational instructors, shellfish propagation officers, weights and measures inspectors, and other expenses of programs providing classroom education to participating senior citizens, programs providing recreational activities to participating residents of the Town, shellfish seed stock and related shellfish propagation equipment and shellfish merchandise purchased for resale, weights and measures enforcement, production of GIS reports and, expenses related to the promotion of arts and culture programs and expenses related to the support and promotion of the town's asset management program.

(3) The total amount spent during a fiscal year shall not exceed the amount authorized by the Town Council on or before July 1 of that fiscal year, or any increased amount of that authorization that is later approved during that fiscal year by the Town Council.

C. Interest earned on any revolving fund balance shall be treated as general fund revenue of the Town.

§ 86-9 Annual Spending Limitation.

Annually, at the time the Town budget is submitted to the Town Council, the Town Manager shall submit an order to the Town Council authorizing the spending limitation for each revolving funds set forth in § 86-7.

§ 86-10 Annual report.

At the end of each fiscal year, the Finance Director shall report to the Town Manager the total amount of receipts and expenditures of each revolving fund for the prior fiscal year. The program directors shall report to the Town Manager the programs, services and participants served by each of the programs. The Town Manager shall forthwith cause a report to be made to the Town Council, together with such other information, as the Town Council shall require.

§ 86-11 Revolving Fund closure.

In the event that a revolving fund is not continued in the following fiscal year, the balance in the fund at the end of the fiscal year shall revert to the general fund surplus revenue unless the Town Council, upon the recommendation for a transfer from the Town Manager, votes to transfer such balance to another revolving fund.

RATIONALE: Due to the reorganization proposed as part of the fiscal year 2019 operating budget several changes are needed to the town's existing ordinance on revolving funds. Three revolving funds are no longer used (Adult Social Day, Building Permits and Police Training) and others are moved to new departments. In addition, a new revolving fund (Asset Management) has been created.
