

Town Council Meeting April 25, 2019



quorum being duly present, President James Crocker, Jr. called the April 25, 2019, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Crocker regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Crocker followed by a moment of silence, Vice President Flores asked everyone to keep in their prayers the family of Bill Ford and President Crocker asked everyone to keep in their prayers the family of Sheila Guiler.

PUBLIC COMMENT:

Tina Carey felt the Hyannis Main Street Waterfront Historic District Commission had issues with BID members regarding open meeting law and conflict of interest. (EXHIBIT A)

Michael McNally urged the Barnstable Police Department to review how cyber-crimes are filed and handled. He feared for the safety of Barnstable citizens with this type of on-line threatening behavior.

Heather Hunt suggested the steering committee, for the short term rental tax should be open to include a Barnstable citizen, who was concerned with the quality of life, as a member.

Laura Kelley from Protect Our Cape Aquifer urged Council to eliminate the use of all glyphosate herbicide products on Town property. She suggested using the Organic Materials Review Institute approved list of herbicides.

Dick Schiffman felt the flooding was an issue with the Commerce Road area. He hoped Council would approve the agenda item as this was an urgent matter.

Sue Phelan explained due to a citizen's petition the Barnstable County was holding a meeting at the Barnstable Town Hall in the Hearing Room on May 2 from 5:00 – 6:30 pm. This

meeting was regarding the Barnstable County Fire and Rescue Training Academy and she hoped the public would attend.

Assistant Town Manager Andy Clyburn introduced Katie Service, Airport Manager, and Louis Masiello, Senior Vice President of Development, from WS Development. He thanked all the parties involved in reaching this agreement. Katie Service gave an overview of the PowerPoint Presentation. She discussed the need for a longer than 20 year lease, which would need Council approval per Massachusetts General Law Chapter 90. Louis Masiello thank all who were involved in this agreement and added he felt as WS Development was a partner with the airport on this project. He gave background information on his company and discussed the Landing rename of Cape Town Plaza.

What will the front views of the project look like? [It will be similar to Mansfield Crossing] Please make sure to keep the project pedestrian friendly. Disappointed there were no housing elements as part of the overall design. [No housing because the Federal Aviation Administration and WS Development could not agree so WS Development is offered money instead of the housing component] Will there be entertainment? [Yes some examples are: movie theaters, bowling facilities, and escape rooms]
