

Town Council Meeting November 19, 2020



The November 19, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation.

A quorum being duly present, President Paul Hebert called the November 19, 2020 Town Council meeting to order at 7:00 p.m. from a remote location.

An announcement was made by President Hebert regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Paul Hebert; Councilor Eric Steinhilber spoke about the passing of Fran Manzelli and asked that we keep his family and friends in our thoughts and prayers followed by a moment of silence.

PUBLIC COMMENT:

Councilor Response to Public Comment:

Joanne Uchman, member of Centerville for Concerned Citizens expressed disappointment with the Town's decision to not appeal the lower court ruling in T-Mobile's lawsuit regarding the cell tower located at the South Congregational Church in Centerville.

Pete Sampou, scientist and teacher supported agenda item 2021-045, and felt climate change was a global issue.

Bob Wilson said parcel 280 Old Falmouth Road near his home was not compliant with the noise variance.

Steve Semour supported agenda item 2021-023.

Susan Phelan, a resident of Plum Street supported agenda item 2021-023.

Martin MacNeely felt the withdrawal and do-over of the Short-Term Rental ordinances was a complete waste of time.

Jan Ward supported agenda item 2021-045 and noted one cannot have health without environmental changes.

Michelle Sgarlat supported agenda item 2021-045 and hoped for more earth friendly green friendly policies.

Grove Harris supported agenda item 2021-045 and hoped other towns on the Cape would embrace the climate policy.

Keith Lewison supported agenda item 2021-045 and spoke on behalf of his students at the Cape Cod Academy.

Jay Cornwall supported agenda item 2021-045 and explained about sea level rising and storms affected by climate changes.

Allen Sundelin supported agenda item 2021-045 and added his concerns about climate changes.

Chuck Tuttle had concerns with the 310 Main Street Centerville property as a pump station. He hoped The Town would look at other property for the pump station.

Chime Pelzom supported agenda item 2021-045 and called for people to take the first step and work together.

Jim Wolf, Cape Cod Air Sustainability Initiative Director supported agenda item 2021-045 and noted Cape Cod Air would be fully electronic by middle of the decade.

Greta Nelson supported agenda item 2021-045 and felt small groups can make tangible change to complete a goal.

Bobbi Tu expressed concerns about hunting on land near Plum Street.

Gloria Gilbert thanked Council for prohibiting hunting on Plum Street.

Close public comment

Councilor response to Public Comment:

Councilors thanked all people who spoke tonight and commended the younger residents for speaking out and hoped it would encourage others to attend Council meetings.

Mark Ells addressed 280 Falmouth Road issue: the 310 Main Street action was being taken with a site pump station at Mother's Pond road but the title needed to be cleared before the Town will release the 310 Main Street property.

Mark Milne, Finance Director spoke about revaluation of all Barnstable property. He explained every 5 years Barnstable property was revaluated, reassessed and revalued. This revaluation was based on the 2019 sales. He mentioned the revaluation was pre-COVID-19. He noted if there were any concerns with home owner assessments to contact the Board of Assessors at (508) 862-4022

- Barnstable has reached red status. If Barnstable stays at red status for 3 weeks then town may have to move down a step. Barnstable is currently in Phase III Step II
- Capital Operating budget Fiscal Year 2022
- Economic Development Task Force

Dan Santos, Public Works Director gave an update to the Comprehensive Wastewater Management Plan. He explained the plan was submitted on November 13 to MEAPA and we will have a decision by the end of December 2020. The decision will then be submitted to the Cape Cod Commission. He noted there was no need information regarding the Joint Base Cape Cod plan. He discussed the projects: Mother's Park Road, Phinney's Lane and Route 28 pump station. He noted the ongoing projects until March 2021: Strawberry Hill Road, Vineyard Wind and nutrient trading with Town of Sandwich. (Rapp Grassetti) What about our neighbors to the east? [Yarmouth is partnering with Harwich and Dennis] (Neary) [Study is ongoing effluent disposal in and out of town]

There is public input at the second Thursday of the month meeting. She noted the draft ordinance was available on the committee's webpage. (Hebert)

Roy Catignani, Chairman Waterways Access Subcommittee and Ali Maloney spoke about their committee's mission. The group would like to improve waterfront access. He addressed their 5 initiatives: recognize mooring fields, standardizing moorings, transit slip mooring rentals, enhance parking at ramps, and park redevelopment parcel of land at waterfront.

Kalmus Beach is a great asset. Boating on ocean needs to start with looking at access from there to Town. Develop docking area for boating. (Schnepp)

Growth incentive goals: Regulations allow for top of shopping housing, traditional mix of uses, expand and simplify code, move away from antiquated zoning regulations and cohesive transparent process for planning,

Elizabeth Jenkins Planning and Development Director spoke about downtown Hyannis rezoning development and gave an overview with a PowerPoint Presentation. She mentioned there is a draft of the code on the Planning and Development website.

He felt this policy would strengthen the strategic plan.

(Neary)

Felt this policy could be micromanaged due to interpretation and was redundant.

(Rapp Grassetti)

We could rework the language.

(Steinhilber)

He felt rewriting the item was not a good idea.

(Schnepp)

We should not ignore this issue net zero is a challenge and a goal to reach.

(Levesque)

There is a concern with the sense of urgency as climate change is preventable.

Upon motion which was duly seconded it was to move past 11 o'clock

VOTE: PASSES 11 YES

(Shaughnessy)

To not approve this item is insulting to the people who came out tonight and spoke in favor of the item. This is not micromanaging or vague language. (Steinhilber)

During the discussion I amended my motion language to work with the sponsors to tighten and make the language clear and consistent with the Strategic Plan.

Upon motion which was duly seconded it was to table the amendment and to work with the sponsor to tighten up the language and better align with the language of the Strategic Plan VOTE: FAILS 4 YES 7 NO (BOGAN, CLARK, RAPP GRASSETTI, HEBERT, SCHNEPP, SHAUGHNESSY, AND STARR)

Upon motion which was duly seconded it was

RESOLVED: That due to the threat posed by global climate change to the health, safety and economic security of the residents of the Town of Barnstable, including rising seas, deadly storms, dangerous heat waves, acidifying oceans and melting ice sheets, and in recognition that this climate emergency is driven by human energy consumption and land use practices, the Town of Barnstable hereby adopts as its policy the objective of reducing net greenhouse gas emissions from human activity within and by the Town to zero to the extent technically and economically feasible; and the Town Manager is hereby directed, in consultation with the officers and departments of the Town, to identify and recommend to the Council measures that may be taken by the Town to facilitate such policy and objective.

We could have a one hour discussion on December 3rd with a subsequent 2 hour meeting to get closure on some and possibly all policies. If this does not happen then we will continue to another meeting in the future.
